

Records of the Salem Witch-Hunt Updated Archival Citations, July 8, 2023

Two volumes of manuscripts from the Court of Oyer and of the Salem witchcraft trials in 1692 and 1693 have been on deposit at the Phillips Library of the Peabody Essex Museum since 1980, where they were transferred for safe-keeping from the courthouse in Salem, Massachusetts, in 1980. The Phillips Library scanned them for the Library's on-line portal and then, in 2023, delivered them to The Massachusetts Supreme Judicial Court Archives in Boston, where they belonged. In addition, they transferred thirty more witchcraft documents from their own collection, inherited from the Essex Institute Archives. Because the manuscripts have been moved, the archival citations as printed in *Records of the Salem Witch-Hunt* (2009) are now out-of-date. This document provides the updated archival citations for all entries that are listed as being at the Phillips Library.
